What is BRC?

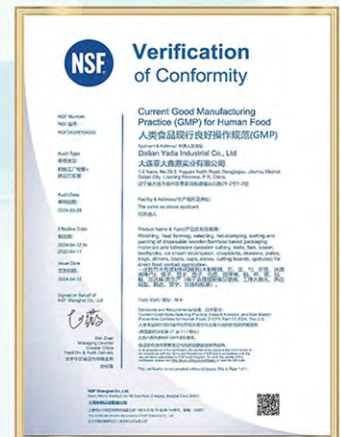
BRC is an international Food Safety Management Systems standard and is one of the GFSI (the Global Food Safety Initiative) recognized certification schemes. It contains requirements for food processors to follow to build an effective food safety management system. For the purposes of certification, the food industry is broken down into five key categories: Food Safety, Packaging and Packaging Materials, Storage and Distribution, Agents and Brokers, and Consumer Products.

### What is GMP

Good Manufacturing Practices or GMP is a system that consists of processes, procedures and documentation that ensures manufacturing products, such as food, cosmetics, and pharmaceutical goods, are consistently produced and controlled according to set quality standards. Implementing GMP can help cut down on losses and waste, avoid recall, seizure, fines and jail time. Overall, it protects both company and consumer from negative food safety events.

GMP examine and cover every aspect of the manufacturing process to guard against any risks that can be catastrophic for products, such as cross-contamination, adulteration, and mislabeling. 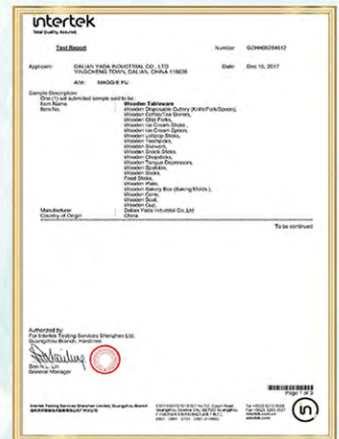
